Note :- (3) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (4) The candidates who have secured **62.33 (sixty two (point) three three)** marks and above are included in the Main list of the Short List and the requisite marks have been lowered to the extent necessary with respect to the supplementary list.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification, Physical Measurement and Practical Test (T-Test + Road Test). **Date, Time and Venue of OTR Verification, Physical Measurement and Practical Test of candidates included in this Short List will be published shortly.**

Note :- (6) Candidates called for the Practical test should produce a Medical certificate in the prescribed form in original containing all relevant details from a Medical Officer not below the rank of an Assistant Surgeon/ Junior Consultant and also a Medical Certificate regarding eye sight from an Ophthalmologist in Government Service (form of Medical Certificate is appended with the Gazette Notification for this post). Candidates can download their Admission Ticket for **Physical Measurement and Practical Test** through their One Time Registration profile after finalisation of date of Practical test.

Note :- (7) The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (8) According to the existing procedure, reevaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the rank of Tahsildar or EWS Certificate, as applicable issued by the revenue authority along with other documents at the time of OTR verification.

Note :- (10) Copy of answer scripts of the OMR Test held on **05-09-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to **Notification No: ERXVI(1)4674/22/EW dated 30/12/2022.**
