Note :- (3) The candidates who have secured 60.67 (**Sixty (point) six seven**) marks and above are included in the Main List of the Short List and requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for Physical Measurement and Practical Test (T Test and Road Test). **Date,time and Venue of Physical Measurement and Practical Test will be informed to the candidates through profile message and SMS.** The shortlisted candidates should download their Admission Ticket for the above test from their OTR profiles ,logging on to the official website "www.kerala psc.gov.in" of Kerala Public Service Commission and appear for the test with necessary documents. They shall upload a Medical Certificate, in the format Prescribed in the Notification,consisting of PART A regarding "VISION" obtained from an Ophthalmologist in Govt Service and PART B regarding "PHYSICAL FITNESS" obtained from a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant in Govt. Service in their OTR profiles and produce the Original Medical Certificate at the Time of Physical Measurement and Practical Test.

Note :- (5) The Scheduled Caste /Scheduled Tribe candidates included in the Short List are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of Community Certificate Rules 2002 by the Revenue Authority not below the rank of Tahasildar, candidates belonging to other reservation communities are required to produce Non Creamy Layer Certificate as per GO(P) No 81/09/SCST DD dated 26/09/2009 issued by Village Officer and those belonging to Economically Weaker Section category are required to produce EWS Certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 and GO(MS) No 23/2022/P&ARD dated 04.10.2022 along with other relevant documents to prove date of birth,qualification and weightage at the time of One Time Registration Verification to be held on the date of Practical Test.

Note :- (6) According to the existing procedure, revaluation of Answer scripts is not allowed but Answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **05-09-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note;-(8) Candidates whose Register Numbers are invalidated are advised to refer to Notification No ERXVI(1) 4674/22/EW dated 30/12/2022.
