Date ,Time, and Venue of the said Test will be intimated in due course through SMS and profile Message. The shortlisted candidates should download their Admission Tickets for the above test from their OTR profiles ,logging on to the official website"www.keralapsc.gov.in" of Kerala Public Service Commission and appear for the test with necessary documents.The shortlisted candidates are directed to produce a Medical certificate (in the form prescribed as per the notification) issued by a Medical Officer not below the rank of Assistant Surgeon/Junior Consultant at the time of Physical Measurement and Physical Efficiency Test.

Note:-(4) The Physical Measurements of candidates will be taken prior to the Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note;-(5)According to the existing procedure revaluation of answer scripts is not allowed. But, Answer scripts can be rechecked after the publication of ranked List. Detailed instructions will be issued in the ranked list to be published for the post.

Note :- (6)The candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No 81/09/SCSTDD dated 26/09/2009 issued by Village Officer and those belonging to SC/ST are required to produce Community Certificate (in form III/Digitally signed) issued by the Revenue authority not below the rank of Tahsildar along with other documents to prove date of birth ,qualification, weightage etc at the time of OTR verification to be held on the date of Physical Efficiency Test.

Note:-(7)Copy of Answer script of the OMR Test held on 26/02/2022 will be issued to those candidates who apply for the same remitting the prescribed fee after the approval of the Ranked List.
