- NOTE (1)** :- The Ranked List for Direct Recruitment will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of 3 years whichever is earlier. The candidates included in the list shall be advised against the 5% vacancies arising in the cadre of Clerk Typist/Typist Clerk reserved for the persons holding posts having scale of pay below Rs. 19,000 – 43,600/- included in the subordinate service for them purely on the basis of merit. In case the candidates included in the Ranked List couldn't secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of Low Paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly (Vide G. O. (P)No.39/89/P&ARD dated 08.12.1989).
- NOTE (2)** According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website www.kerala-psc.gov.in by remitting the prescribed fee of Rs. 85 (Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission.
- NOTE (3)** Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 30 (Thirty) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
- NOTE (4)**: Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer sripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.
- NOTE (5)**: The A part and B part of OMR scripts will be destroyed after completing a period of 6 months from the date of finalisation of the last Ranked list included in the Common test.
- NOTE (6)**: The candidates who wish to relinquish their claim for advice from the Ranked List shall make the same in the format prescribed by the Commission to The District Officer, KPSC District Office, Kasaragod. The format is available in the official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized

affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (7): The date of publication of Ranked List in the website is 15.05.2023. This date will be considered only relinquishment.
