Note :- (8) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (9) Copy of answer scripts of the OMR Test held on 26-03-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts of candidates are invalidated as per Notification No : ER IX(3)2710/2022/EW Dated 26/04/2023.
