NOTE 2) According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs.85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the District Officer, Kerala Public Service Commission, District Office, Kasaragod 671121. Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed

to candidates with effect from the date of publication of the Ranked List in the official Website of the Commission (on or before 31.05.2023). The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE 3) Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission, District Office, Kasaragod 671121. within 30 (Thirty) days from the date on which this Ranked List is uploaded in the Commission's Website. A copy of answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 31.05.2023 Applications received after the prescribed date will not be entertained.

NOTE 4) The entries put in column (9) are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Kasaragod 671 121 within one month from the Date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.
