Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (In form III/ Digitally signed Certificate) issued by the competent Revenue authority not below the rank of Tahsildar as specified in Kerala Gazette and candidate belonging to other reservation Communities are required to produce a Non Creamy Layer Certificate as per **GO(P) No. 81/09/SC/ST/DD dated 26.09.2009** issued by the concerned revenue authority at the time of OTR Verification.Candidates belong to **EWS** category should produce **EWS** Certificate issued by concerned revenue authority.

Note :- (7) Copy of answer scripts of the OMR Test held on **15-11-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. As per Notification No : ER VII(1)353/2023/EW dated 16.02.2023 the register number of no candidates are invalidated in connection with the above OMR Test..
