Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy layer Certificate as per GO(P) No:81/09/SC/STDD dated 26.09.2009 and SC/ST Candidates included in this list are required to produce Community Certificate in Form III or digitally signed by the Revenue authority not below the rank of Tahsildar and EWS candidates are required to produce EWS Certificate issued by the authority concerned along with other documents mentioned above at the time of verification of original documents.

Note :- (9) Copy of answer scripts of the OMR Test will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
