Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of a Tahsildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority at the time of Verification. Candidates belong to EWS category should produce EWS certificate issued by concerned Revenue authority.

Note :- (7) Copy of answer scripts of the OMR Test held on 05-09-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : ER XVI(I)4674/2022/EW dated 30/12/2022
