Note 2. The Register number of candidates who have secured top mark in the OMR Test (Common preliminary Exam(Tenth Level) are included in the list.

Note 3. The candidates who have secured 73.33 (seventy three(point) three three) Marks and above after standardisation in the Preliminary OMR test are included in the Eligibility list. The minimum marks for inclusion in the list of candidates belonging to Scheduled Tribe community have been lowered to ensure their adequate representation in the Eligibility list. Note 6. According to the existing procedure, revaluation of Answer Scripts is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/-(Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
