Note 1. Inclusion of Register numbers in this list is purely provisional. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared on the basis of the Main Examination.

Note 2. The register numbers of candidates who have secured top mark in the OMR Test(Common Preliminary Exam) are included in the list.

Note 3. The candidates who have secured **66.33 (sixty six (point) three three)** Marks and above in the Preliminary OMR test are included in the Eligibility list. The minimum marks for ST reservation community have been lowered to ensure their adequate representation in the Eligibility list.

Note 4. The marks secured in the Common Preliminary Examination by the candidates will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note 5. If any of the documents produced by any candidate is found defective, the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure revaluation of Answer Script is not allowed. But, Answer scripts will be rechecked if the candidates apply for through their OTR profile from the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs 85/-(Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15(Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates w.e.f the date on which the eligibility list is uploaded in the website of the Commission.

Note 7. Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to the candidates with effect from the date on which the Eligibility List is uploaded in the website of the Commission. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
