No.02/2020/P&ARD,Dated : 12.02.2020) issued by the Revenue authority concerned at the time of OTR Verification.

**Note:- (6) :-** The register number of those candidates who do not produce the required document within the prescribed time limit and whose applications found otherwise defective will be deleted from the probability list without further notice.

**Note :- (7) :-** For Online Examination rechecking and revaluation is not allowed. but printout of answer sheet of the **ONLINE Examination** held on **31-08-2022** will be issued to those candidates who apply for it by remitting the prescribed fee after approval of the Ranked List.
