Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found other wise defective will be deleted from the Short List with out further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to other backward classes included in the short list are required to produce Non creamy Layer certificate as per G O (p) No 81/09/Sc/St/DD dated 26/06/2009 and SC/ST candidates included in this list are required to produce Community certificate in Form III or digitally signed and issued by the Revenue authorities not below the rank of Tahsildar and the candidate who claim EWS reservation are required to produce EWS certificate vide G O No 2/2020 P&ARD dated 12/02/2020 along with other documents mentioned at the time of OT verification of original documents
