Note :- (6) The Register Number of candidates who do not produce the required document within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No. 81/09/SC/ST/DDdated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.
