Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate(in Form III/Digitally Signed)issued by the competent Revenue Authority ;candidates belonging to Other Reservation Groups should Produce Non Creamy Layer Certificate issued by the Village Officer as per GO(P)No 81/2009/SCSTDD dated 26/09/2009 and those belonging toEconomically Weaker Section Category are required to produce EWS Certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevent documents at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **27-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
