Note :- (7) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O(P) No. 81/09/SC/ST/DD dated 26.09.2009,candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahisildar and candidates belonging to Economically Weaker Section are required to produce EWS certificate issued by the cocerned authority at the time of OTR Verification.

Note :- (8) For Online Examination,rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List.
