Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/ SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O(Rt)No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of Issue of Community Certificates Rules, 2002 and the candidate who claim EWS reservation are required to produce EWS certificate vide G.O No. 2/2020 P&ARD dated 12/02/2020 along with other documents mentioned at the time of OTR verification of original documents.
