Note :- (6) The register number of candidates who do not produce the required document within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on 07/11/2021 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
