Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (6) Candidates included in the Probability List, eligible for reservation, are required to produce Non Creamy Layer Certificate as per G.O (P) No. 81/09/SC/ST/DD dated 26.09.2009/ Community Certificate issued by the Revenue authority and shall produce the same at the time of OTR Verification.

Note:- (7) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (8) Copy of answer scripts of the OMR Test held on **25.09.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER XIV (3) 4134/22/EW dtd. 20.07.2023
