**NOTE (1) :-** The Ranked List shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the pending vacancies and also for the vacancies reported for Special Recruitment from Scheduled Castes/Scheduled Tribes during the currency of the Ranked List. As the advice for appointment depends on occurrence of vacancies. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

**NOTE (2) :-** Candidates who wish to obtain image and tabulation sheet of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five Only) via e-payment mode available in the portal. A period of 15 (fifteen) days time to apply for photocopy of answer sheets will be allowed candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie, **on or before 08/08/2023**). Application submitted in any other manner (ie, via Email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued.

**NOTE (3) :-** The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the **The District Officer, Kerala Public Service Commission, District Office, Civil Station (P.O), Malappuram-676505** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (4) :-** The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **The District Officer, KPSC District Office, Civil Station (P.O), Malappuram 676505**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The attestation by the notary shall bear the statement that "Solemnly affirmed and signed before me by the deponent on the day on this the .....day of .....in my office at ....." The application with the affidavit mentioned as above alone will be accepted. The request for relinquishment received **within 15 days** from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (5) :-** Since a common ONLINE test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of ONLINE test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.
