Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whoes applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates belonging to Other Backward classess included in this list are required to produce Non-Creamy Layer Certificate as per G.O(P) No 81/09/SC/STDD dated 26/09/2009, candidates beonging to SC/ST are required to produce community certificate in Form III or Digitaly Signed by the Revenue Authority not below the rank of Thahsildar and candidates belongigng to Economically Weaker Section are required to produce EWS certificate issued by the concerned authority at the time of OTR verification.

Note :- (7) For Online Examination, rechecking and revaluation are not allowed but print out of answer sheet will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instruction will be furnished in the Ranked List to be published for this post.
