Note :- (7) The register number of those candidates who do not produce the required documents within the prescribed time limit and those applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (8) SC/ST candidates included in the Short List are required to produce Community Certificate in Form III /Digitally signed and candidates belonging to other reservation groups are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SC/STDD dated 26.09.2009 or EWS Certificate, as applicable issued by the Revenue authority at the time of OTR Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on 15.11.2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated as per Notification No : ERVII(1)353/2023/EW dated 16/02/2023.
