Note :- (6) Candidates included in the Short List who are eligible for reservation required to produce Non Creamy Layer Certificate as per GO (P) NO -81/09//SC/ST/DD dated 26/09/2009 and SC/ST Candidates are required to produce Community Certificate issued by the Revenue Authority and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(MS) No 2/2020/P & ARD dated 12-02-2020 issued by the Revenue authority along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **01-11-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
