Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the SC/ST category included in the Probability List are required to produce Community Certificate (Form III / Digitally signed) issued by the Revenue authority at the time of OTR Verification. Those belonging to other reservation groups should produce Non creamy layer certificate for state employment purpose as per GO(P)No.81/09/SC/STDD dated 26.09.2009. Those included in the EWS list should produce the relevant EWS certificate issued by the Revenue authorities.

Note :- (7) Copy of answer scripts of the OMR Test held on 26-10-2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated for the above mentioned post as per Notification No :ERVII(2)670/2023/EW dt.02.03.2023
