Note (2) :- The list has been prepared by including the number of candidates who have secured top marks in the OMR Test. requisite marks have been lowered to the extent necessary in respect of Supplementary Lists

Note (3) :- 10 (Ten) candidates who have secured top most marks in the OMR examination are included in the Main list of this short list. The mark secured by the last candidate in the main list is 22.67 (Twenty Two (point) Six Seven) Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribe, Other Backward Classes and other reserved categories necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note (4) :- The Short List is prepared on the basis of details furnished by the candidates in the application and subsequent claim made will not be entertained at any stage for this post.

Note (5) :- Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification and Interview will be published shortly.**

Note (6) :- According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note (7) :- Candidates included in the Short List are required to produce Community Certificate in the case of SC/ST candidates, Non Creamy Layer Certificate in the case of candidates included in the Other Backward Communities, EWS Certificate in the case of candidates included in Economically Ewaker Section issued by the Revenue authority at the time of OTR Verification.

Note (8) :- Copy of answer scripts of the OMR Test held on **07-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER II(2)3284/2023/EW Dt.07.09.2023.
