Note :- (3) **20(Twenty)** candidates who have secured top marks in the OMR Examination are included in the Main List of this Probability List. The Mark secured by the last candidate in the Main List is **71(Seventy One)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled tribes, other backward classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Probability list should be present in person and produce the original documents for One Time Verification. Date, Time and Venue of OTR Verification will be intimated through Profile Message and SMS.

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability list without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Probability List are required to produce Community Certificate/Non Creamy layer Certificate as per G.O (P) No.81/2009/SC/ST/DD dated 26.09.2009 and those belong to EWS category are required to produce EWS Certificate in the format prescribed vide G.O(MS)No:02/2020/P&ARD dated 12.02.2020 in proof of their claim along with other relevant documents at the time of One Time Verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on 18-05-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
