Note :- (2) The Shortlist is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) 211 (Two Hundred and eleven) candidates who have secured top most marks in the OMR examination are included in the Main list of the Short list. The Marks secured by the last candidate in the main list is **63.67 (Sixty three (point) six seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of the merit of the candidates belonging to such classes

Note :- (4) An Endurance Test will be conducted for the candidates included in the short list. Date, time and Venue will be intimated in due course by SMS/Profile message.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 , SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 09-05-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERXVI(3) 3611/2023/EW dated 03.10.2023.
