Note :-(2) The Shortlist is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :-(3) 10(Ten) candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short List. The mark secured by the last candidate in the Main List is **44.33 (Forty Four point three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :-(4) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification and Interview. Date,time and Venue of OTR Verification and Interview will be published in due course.

Note :-(5) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Shortlist without further notice.

Note :-(6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post

Note :-(7) SC/ST candidates included in the Short List are required to produce Community Certificate(in Form III/Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SC/STDD dated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in proof of their claim along with other relevant documents at the time of OTR Verification of original documents.

Note :-(8) Copy of answer scripts of the OMR Test held on **04-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VI(3)2403/2023/EW.
