Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The list has been prepared by including the eligible and qualified candidates who have secured top most marks in the OMR Test.

Note :- (3) **91 (Ninety One)** - candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **81.67 (eighty one (point) six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other backward Classes (and other reserved category if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. Date, time and Venue of OTR Verification and interview will be published in profile through Profile Message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and Candidates belonging to Economically Weaker Section (EWS) are required to produce certificate issued by the competent Revenue Authorities as per GO (MS) No. 2/2020/P&ARD dated 12.02.2020 at the time of OTR verification and interview.

Note :- (7) Copy of answer scripts of the OMR Test held on **31-05-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No. ER VI(3)3297/2023/EW dated 20.11.2023.
