The following is the list of candidates for selection to the post of WOMEN CIVIL EXCISE OFFICER (FIRST NCA DHEEVARA) on Rs 20,000-45800/- (PR) in EXCISE DEPARTMENT in KOLLAM DISTRICT found suitable by the Commission and arranged in the order of merit based on the OMR test held on 19.05.2023, Endurance Test held on 20.11.2023, Physical Measurement and Physical Efficiency Test held on 24.01.2024 for recruitment against the NCA vacancies for Dheevara Community only. This NCA Ranked List is brought into force with effect from 09.04.2024 and will be valid until candidates are advised and appointed against vacancies that arise due to the paucity of candidates belonging to Dheevara community, during the currency of Mother Ranked List published on 30.04.2021 for the post (cat no:501/2017)

NOTE (1) :Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to District Officer, Kerala Public Service Commission, District Office, Kollam-691001. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which she is to be advised.

NOTE (2) :-According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's official website by remitting the prescribed fee of Rs.85 (Rupees Eighty-Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie on or before 26.04.2024)

NOTE (3) :-Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before 26.04.2024) . Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4) :- Since a common OMR test with common candidates was conducted for the post, the marks awarded to the candidates included in the Ranked List will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer script will be intimated in due course, but photocopy of OMR script will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (5) :-The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalization of the all Ranked Lists included in the common test held on 19.5.2023.
