The fee can be remitted by e-payment through the portal. Applications submitted in any other manner ,ie ,Email/Tappal/By hand,will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. ie on or before 24/07/2023.) Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission (www.keralapsc.gov.in) by remitting the prescribed fee of Rs. 335 (Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission, ie, on or before 24/07/2023. Application submitted in any other manner ,ie, Email/Tappal/By hand, will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 24/07/2023. Applications received after the prescribed date will not be entertained.

NOTE (4) :- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the **The District Officer Kerala Public Service Commission ,District Office ,Civil Station PO, Kannur, 670002** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (5) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to The District Officer Kerala Public Service Commission ,District Office ,Civil Station PO, Kannur, 670002. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinguishment be Gazetted should attested by a Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of uploading of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
