Note :- (7) Copy of answer scripts of the OMR Test held on **24-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer Scripts of Candidates are invalidated as per Notification No : ER2-1/7/2024-KPSC dated 10.06.2024.
