A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie, on or before **07.08.2024**.). Application submitted in any other manner (i.e.via email/ Tappal/ Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Printout of the answer sheets invalidated due to any deffect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, an legal proceedings will be intiated against those who do so. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the Official Website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
