Copies of answer scripts invalidated due to any defect will not be issued.
- **NOTE (3)**:- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to The District Officer, kerala Public Service Commission District Office, Kasaragod. within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.
