Note :- (3) 175 ( One Hundred And Seventy Five ) Candidates who have secured top most marks in the OMR Test are included in the Main list of the Short list. The marks secured by the last candidate in the Main list is **46.67 ( forty six (point) six seven )** marks . For satisfying the rules of reservation of appointment to Scheduled Castes , Scheduled Tribes , Other Backward Classes and EWS Category , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes .

Note :- (4) Candidates included in the Short List should be present in person for **Endurance Test** . **Date,time and Venue of Endurance Test will be intimated through SMS, Profile message and through Print and Electronic Media. The shortlisted candidates should download their Admission Tickets for the Endurance Test from their OTR Profiles logging on to the Official Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of the Kerala Public Service Commission and appear for the test with necessary documents .**

Note :- (5) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by Village Officer as per GO ( P ) No. 81/09/SCSTDD 26.09.2009. ,SC/ST candidates included in the Short List are required to produce Community Certificate(in FormIII/Digitally Signed) issued by the competent Revenue Authority and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevent documents at the time of OTR Verification of original documents. .

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER 2 - 3/ 9 / 2024 - KPSC dtd 27/06/2024 .
