The Marks secured by the last candidate in the Main List is **62.67( sixty two (point)six seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes, Economically Weaker Section and Differently Abled categories, necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

**Note :- (4)** The Short list is prepared based on the details furnished by the candidates in the applications and subsequent claims made will not be entertained at any stage.

**Note :- (5)** Candidates included in the Short List should present and produce in person the original documents for OneTime Verification and Interview. **Date, time and Venue of OTR Verification and Interview will be published in due course.**

**Note:- (6)** Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahilsdar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority at the time of OTR verification.

**Note :- (7)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the OMR Test held on 17-04-2024 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.
