Note :- (6) Candidates belonging to SC/ST included in the Short List are required to produce Community Certificate issued by the competent Revenue Authority and candidates belonging to Other Reservation Groups are required produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer/EWS Certificate vide GO (M S) No.23/2022/P&ARD dated 18.10.2022 issued by the Village Officer in proof of their claim along with other relevant documents at the time of OTR Verification of original documents
