Candidates who wish to obtain a photocpy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335 (Rupees Three Hundred and Thirty- Five only) via e-payment mode available in the portal.
