Note :- (3) **10 (Ten)** Candidates who have secured top most marks in the OMR Examination are included in the MainList of this Short List . The marks secured by the last candidate in the Main List is **63.67 (sixty three (point) six seven)** marks .For the purpose of satisfying rules of reservation of appointments to Scheduled Castes, Scheduled Tribes, Other Backward Classes,Economically Weaker Sections ,necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce original documents for One Time Verification and Interview. Date,time and Venue of One Time Verification and Interview will be intimated in due course.

Note :- (5) Candidates belonging to Other Backward Classes, included in this List, are required to produce NonCreamy Layer Certificate as per G.O(P) No.81/2009/ SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates included in the List are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (MS) No 2/2020/P&EA dated 12/02/2020 issued by the Revenue Authority, along with other documents at the time of One Time verification.

Note:-(6)The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **12-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer the Invalidation notification No.ER6-2/3/2024-KPSC dated 31/07/2024.
