Note :- (2) 11(Eleven) candidates who have secured top most marks in the OMR examination are included in the Main List of the Short List. The Marks secured by the last candidate in the Main List is **46.33 (forty six (point) three three)** marks . For the purpose of satisfying the rules of reservation of appointment to Scheduled caste, Shceduled Tribe, Other Backward Classes (and other reservation Categories if any) necessary supplementary lists prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification and interview will be intimated in due course.**

Note :- (4)The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SC/STDD dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate (in Form III/ Digitally signed) by theCompetent authority not below the Rank of Thasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 29-04-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER 16-2/7/2024-KPSC dated 25.07.2024.
