The mark secured by the last candidate in the Main list is **23.67( twenty three(point) six seven )** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section Category, if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

**Note:- (4)** Candidates included in the Probability List should present in person and produce the original documents for One Time Verification. Date,time and Venue of OTR Verification will be intimated through Profile Message &SMS.

**Note:- (5)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

**Note:- (6)**The Register number of those candidates who do not produce required documents within the prescribed time and those application found otherwise defective will be deleted from Probability list without further notice.

**Note :- (7)** SC/ST Candidates included in the Probability list are required to produce Community Certificate( Form III /Digitally signed) issued by the competent Revenue Authority, Candidates belonging Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009 and those belonging to Economically Weaker Section are required to produce EWS Certificate in the format prescribed vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 in proof of their claim along with other relevant documents at the time of OTR Verification.

**Note :- (8)** Copy of answer scripts of the Common OMR Test held on **04-04-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
