Note :- (7) Candidates included in the Short List are required to produce Non-Creamy Layer Certificate as per G.O(P) No.81/2009/SCSTDD dated 26/09/2009 issued by Village Officer and SC/ST candidates, included in the List, are required to produce Community Certificate issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (MS) No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority, along with other documents at the time of OTR verification.
