Economically Weaker Section are required to produce EWS certificate issued by the concerned authority at the time of OTR Verification.

Note :- (6) The Register Numbers of those Candidates who do not produce required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (7) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List.
