Note :- (4) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SC/STDD dated.26.09.2009, SC/ST Candidates are required to produce Community Certificate (in Form III/Digitally signed) by the Competent authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Copy of answer scripts of the OMR Test held on 17-02-2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
