Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated in due course.**

Note :- (6) Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 / Community Certificate /EWS Certificate issued by the Revenue authority and shall produce the same in person along with the other documents at the time of verification of original documents.

Note :- (7) For Online Examination ,rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List.Detailed instructions will be furnished in the Ranked list to be published for the post .
