Note:- (6) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority in the format prescribed in Kerala(Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules,2002 and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents mentioned, at the time of OTR verification of original documents.

Note: (7) Copy of answer scripts of the OMR Test held on 19.04.2024 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
