Note :-(5) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/2009/SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO No.23/2022/P&ARD dated 04-10-2022 issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :-(6) Copy of answer scripts of the OMR Test held on **17-02-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
