NOTE (1) :-For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain a printout of their answer sheets relating to this selection shall submit online application through their One Time Registration Profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs.335/-(Rupees Three Hundred and Thirty Five only)** via e-payment mode available in the portal. A period of 15(Fifteen)days time to apply for print out of answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. (ie, on or before **19.10.2024**). Application submitted in any other manner (i.e.via email/ Tappal/ Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate.

NOTE (2) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to **THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION, HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4**. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
