Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who claimed communal reservation are required to produce Community Certificate/ Non Creamy Layer Certificate / EWS Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **28-06-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated vide Notification No : ER16-1/13/2024-KPSC Dated 03.09.2024.
