For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes, Economically weaker Section and Differently Abled, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be intimated through SMS and Profile message.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (7) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creany Layer Certificate as per G.O. (P) no.81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and an EWS Certificate issued by the village officer as per GO(MS) No.23/2022/P&ARD dtd:18/10/2022 in case of candidates having EWS reservation at the time of OTR.

Note :- (8) Copy of answer scripts of the OMR Test held on **28-06-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per Notification No : **ER16-1/13/2024-KPSC dated 03/09/2024**.
